- Afterschool extracurricular classes information - details will be announced at a later time.

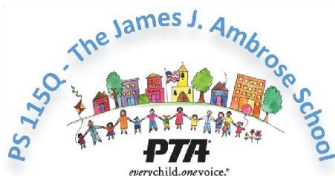
